- 2. The bidders are required to quote the rate strictly as per the terms and conditions mentioned in the Tender document. The conditional tender will not be entertained and shall be liable for outright rejection.
- 3. Bidders must have a registered firm having a **valid GST registration No., PAN No., Aadhar card and Address proof etc.** All the relevant document should be uploaded on GeM portal. The original copy of the document of the bidder can be demanded by the office at any stage. Address should be completed and supported with proof (copies of Aadhar/Voter ID/Passport)
- 4. The bidders should quote the amount for both in words and in figures, if there is any difference between the amount mentioned in figures and that of in words, the rate quoted in words will be taken into account and accepted on record.
- 5. Earnest Money Deposit(EMD) Rs.500/-(Rupees Five Hundred only) should be deposited by way of Demand Draft in favour of "Pay & Accounts Officer, MoH&FW, Chennai 90".
- 6. Offered/Quoted price (Rs.) should not be less than the reserve price fixed but can be more than reserve price. The order will be awarded to the highest bidder on receipt of quote which is more than reserve price. The bidder has to pay GST amount of 18% over and above the reserved quoted price.
